# Fund Profile / Strategy

Intereffekt Active Leverage India is an active mutual fund that uses a dynamic trading model based on a combination of technical stock market indicators. With this trading model the fund actively responds to market developments, whereby the leverage in the fund can vary between 0 and 2. If the trading model generates a positive signal, the leverage will be set at a factor of 2. If the trading model generates a negative signal there will be no leverage relative to the underlying values. The exposure will then be reduced to 0.5, or in extreme cases to a minimum of 0. In the latter case, the fund temporarily will have no exposure on the market at all. The risk profile is high. The fund is aiming for capital growth. The fund will not pay any dividends. The manager will not use a benchmark as a gauge for the purposes of determining the investment policy. For comparison, the sheet shows the return of an index ETF with a permanent leverage of 2. The fund is a subsidiary of Intereffekt Investment Funds N.V. (IIF), established with a so-called umbrella structure.

# Trading

The fund is listed on Euronext Amsterdam and can be traded on trading days through any bank or broker. Orders placed daily before 4 p.m. are settled the following trading day at 10 a.m. based on the net asset value of the fund (plus/minus the usual margin or surcharge).
